2010 IOWA BEEF EXPO LIVE DISPLAY EXHIBIT CONTRACT

We, the undersigned, do hereby request live display exhibit space at the 2010 Iowa Beef Expo to be held February 14th - 21st, at the Iowa State Fairgrounds in Des Moines with exhibit costs as follows:

Live Area Displays: Cost of the live display areas for February 14th - 21st are \$350. Cost of the live display area for any four (4) consecutive days between the dates of February 14th - 21st are \$300. Live displays areas are approximately 10' wide by 12' deep. BEDDING WILL BE SUPPLIED BOTH IN THE OPEN CLASS BARN AND THE TIE OUTS AND IS INCLUDED IN THE COST OF THE LIVE DISPLAY SPACE.

We as display exhibitors agree to abide by all Iowa Beef Expo rules. We understand there may only be one company per exhibit space. (Co-owners of animals qualify as "one company" in live displays.) No space shall be sublet or offered for use by any exhibitor to another exhibitor. No exhibit shall block the view of any other exhibit, or exceed space allotted. Notice of cancellation and request for refund deadline is January 1st. If notice of cancellation is received by that date, a 100% refund will be issued. If notice of cancellation is received after January 1st, live display exhibitors will forfeit \$150 of their initial deposit. No refund will be given for cancellations made after January 20th.

Expo display exhibitors are required to purchase an Expo commemorative pin for \$2, all proceeds go to the Junior Beef Breeds Scholarship program. The \$2 pin charge must be included in your Expo payment.

We reserve the right to fill your space when you vacate it.

CONTRACT AGREEMENT TERMS AND CONDITIONS**

These regulations have been created in the best interest of both the Exhibitor and the Iowa Beef Expo. Please read these regulations in their entirety. By signing and returning a paid contract exhibitors agree to abide by the following conditions.

**SUBLEASING:** No exhibitors may sublet/assign their space or any part whereof.

**LIMITATION OF LIABILITY:** Each exhibitor must make provision for the safeguarding of his goods, materials, equipment and display items at all times. Iowa Beef Expo assumes no responsibility or liability for any property of the exhibitor, which may be located on the premises of the Iowa Beef Expo. Also:

The exhibitor shall indemnify, save and hold harmless the Iowa Beef Expo, their officers or agents, from and against any and all claims, demands, actions, or causes of actions, suits at law, or inequity of any nature or character arising out of or by reason of any act or omission of the exhibitor or its agents in the performance of rights, duties, or obligation of the exhibitor under this agreement.

The Iowa Beef Expo's agreement to permit use of this space contracted herein shall be subject to cancellation by acts of God, or any other circumstances beyond the control of the Iowa Beef Expo which shall prevent the delivery of some or all of the Iowa Beef Expo's obligations herein specified. The Iowa Beef Expo upon the occurrence of such event shall have the right to terminate this agreement without liability of any nature.

**It is further agreed by the parties as follows:**

This contract is incomplete or void until the Iowa Beef Expo receives payment. Cancellations prior to the final payment deadline are entitled to a full refund. Cancellations after the final payment deadline will receive no refunds. No refunds will be made for cancellation of any part of a show, poor attendance or act of God or other circumstances beyond the control of the Iowa Beef Expo.

No individual or company not under contract with the Iowa Beef Expo will be permitted access to the exhibit hall for the purpose of demonstrating their products, distributing advertising material or for any other purpose.
